**Sub:** Request for Inquiry and Appropriate Action Against Ambedkar's India Mission (AIM) informers at AP Secretariat-Reg.

I am writing to bring to your attention a matter of serious concern regarding the unauthorized access to confidential information within various departments of the Andhra Pradesh Secretariat by individuals associated with the Ambedkar's India Mission (AIM), facilitated by Mr. P.V. Sunil Kumar, IPS officer under suspension and former Director General, CID.

It has been credibly learnt that several members of Ambedkar's India Mission (AIM), with the assistance of Mr.P.V. Sunil Kumar have gained entry into Secretariat offices and obtained access to sensitive departmental data. These individuals are transmitting confidential information to external radical groups, thereby fuelling unwarranted agitations. They are also filing frivolous Right to Information (RTI) applications, originating from Kakinada, with an aim to disrupt administrative processes. Further, it has been observed these individuals have been entering the Secretariat premises using vehicle belonging to Mr. P.V. Sunil Kumar.

Such actions constitute a serious breach of confidentiality and pose significant risks to the integrity of the State administration. They also undermine the sustained efforts of our Hon'ble Chief Minister, Sri Nara Chandrababu Naidu Garu, and Sri Nara Lokesh Garu, in promoting Andhra Pradesh as a global investment destination and facilitating major projects such as the proposed Google Data Centre. These disruptive elements threaten to erode investor confidence and impede the State's developmental agenda.

Given the seriousness of the matter, these acts amount to criminal misconduct, breach of confidentiality, attracting provisions under the Andhra Pradesh Civil Services (Conduct) Rules, 1964 and other relevant laws.

In view of the above, I request that an immediate and comprehensive inquiry be ordered to ascertain the extent of unauthorized information leaks facilitated by Mr. P.V. Sunil Kumar and an appropriate disciplinary action be taken against the AIM informers in the AP Secretariat in order to promote accountability and good governance that define our administration.
